

Community Development Block Grant Program (CDBG)


Authorized under Title 1 of the Housing and Community Development Act of 1974, and administrated by the U.S. Department of Housing and Urban Development.

The Program serves primarily low- and moderate-income (LMI) persons and supports:

- Decent housing
- Suitable living environment
- Expansion of economic opportunities

Supplanting Rule

"Assistance (will) ... not be utilized to reduce substantially the amount of local financial support for community development activities below the level of such support prior to the availability of such assistance."



2021-2025 Brookhaven Entitlement Status

Responsible for budgeting, oversight and reporting on \$375,000 annually in CDBG funds towards limited national objectives.




Process, Requirements & Limitations

The city will receive an annual estimate based on the HUD needs formula. The formula is subject to change, and funds are dependent on the annual congressional allocation.

Provide and document a robust citizen input process.

Submit Annual Action Plans and Annual Reports of accomplishments.

Programs are subject to regular federal oversight and project monitoring.



How can funds be used?

Expenditures must demonstrate and document majority service or benefit to low/ mod individuals or households.

	Сар	\$375,000	Examples
Administration	20%	\$75,000	Planning, monitoring, outreach.
Public Service	15%	\$56,250	Job training, some rental/utility assistance, nutrition, childcare.
Public Facilities/ Infrastructure	65%	\$243,750	ADA, energy efficiency, sidewalks, unfunded park improvements in low/mod areas; limited housing repair; some matching funds.



CDBG National Objectives

To be eligible, projects must meet one of three national objectives.

 Benefit to low and moderate income persons or communities

LMI area benefit
LMI job creation/retention
LMI decent housing support

- Elimination of slums or blighting influences
- Urgent need






