Executive Summary

1. Introduction

The City of Brookhaven is designated a Community Development Block Grant (CDBG) entitlement Community by the U.S. Department of Housing and Urban Development (HUD). This designation qualifies the City to receive grant funding from the CDBG program administered by HUD. The program allocates annual grants to assist in the development of viable communities by providing decent housing, a suitable living environment, and to expand economic opportunities, principally for low and moderate income (LMI) persons. To receive an annual allocation of federal grant funds from HUD, Brookhaven submitted a five-year Consolidated Plan outlining strategy to support Brookhaven's LMI community from 2021-2025. Additionally, the City drafts and submits a one-year Action Plan annually. Brookhaven's CDBG Program year runs from July 1- June 30.

The Consolidated Plan includes the amount of assistance the City expects to receive during the plan period and the range of activities that may be undertaken including the estimated benefit to persons of low and moderate income. The Annual Action Plans are required to include project or program specifics, such as location, cost, proposed outcome, and any additional descriptive information for each yearly grant award. Primarily, federal regulations require that funds be aimed where the greatest benefit may be attained for LMI residents. To acquire ample public engagement in all aspects and phases of plan development, the City of Brookhaven interacts with various stakeholders in meetings, public hearings, and with written correspondence. Prior to the adoption of an Annual Action Plan, Brookhaven advertised for and held two public hearings. The one having a minimum 15-day notice, the second a minimum 30-day notice. All comments are recorded and considered in the formulation of the plan. In addition, all comments and responses are included in the appendix of the plan and are forwarded to HUD upon adoption.

2. Summarize the objectives and outcomes identified in the Plan

On February 27, 2023, Brookhaven received notice of the 2023 formula allocation of \$324,527. In every effort to make a timely submission of the 2023 Action Plan, the City is relying on extensive 2021 outreach conducted for the Consolidated Plan, holding 2 public hearings on uses for 2023 funding, and receiving and considering comment from all community members. The activities the City has identified for these funds are included in the 2023 Annual Action Plan.

It is also important to note that the Plan, based on data analysis, identified the Local Target Area of Buford Highway consisting of eight census block groups with a combined 87.97% LMI population. Due to limited resources, strategic investment in this corridor encourages sustained improvements. The area's high need was clearly articulated during public engagement and supported by federal data resources. While targeting the area is not intended to preclude projects in other areas of the city, there is intentional focus on this area of highest need.

3. Evaluation of past performance

During the first year of the City's 2021-2025 Consolidated Plan the City:

The second year of the 2021 - 2025 Consolidated Plan the City utilized an alternative source in addition to reallocated FY2021 funds from Activity 6) Neighborhood Facilities to Activity 5) Sidewalk reconstruction and ADA compliant curb ramps. Utilizing these funds, the City completed construction on ADA compliant curb ramps and sidewalk repair within the Buford Highway Target Area. It is anticipated that this project benefited the entire community of 11,365 residents residing within the census tracts of the target area. During FY2022 staff also researched and began establishing processes for implementing the balance of 2021 projects. It is anticipated all three years will begin in the 2023 Action Plan year.

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

The City strongly encourages public participation in the development of the 2023 Annual Action Plan (AAP). Per the City's Citizen Participation Plan, the public input and comment period for the plan ran for over 30 days, starting May 11, 2023. All comments were required to be submitted by 5:00 p.m. on June 9, 2023. Public comments could be submitted in writing to the City of Brookhaven Community Development Department ATTN: CDBG Administration 4362 Peachtree Road Brookhaven, GA 30319 or through the City's CDBG Program email: CDBG@BrookhavenGA.gov . On May 11, 2023 a draft plan budget was made available on the City of Brookhaven CDBG page, and on June 28, 2023 the full DRAFT 2023 Action Plan was published on that page. Both are available on the website at https://www.brookhavenga.gov/commdev/page/community-development-block-grant-program

Hard copies of notices and the DRAFT plan were made available at Brookhaven City Hall. Requests for hard copies are be made through CDBG@BrookhavenGA.gov or calling 404-637-0500 and requesting CDBG Administration information. Throughout the year and during the plan development period, staff consulted with agency partners, tenant advocates, public safety providers, DeKalb County Continuum of Care to inform development of the 2023 Action Plan. These meetings resulted in the following activities:

- The development and dissemination of Tenant Resource magnets within the Buford
 Highway Target Area by Code Enforcement. By scanning the QR Code on the magnets,
 residents received access to information on their housing rights, how to report a code
 violation and links to resources for services.
- Working with our agency partners, the City was able to have local funds budgeted for
 the development of an Annual International Festival along the Buford Highway
 Corridor. The City issued a resolution designating the CDBG designated target area the
 "Buford Highway Cultural Corridor". The designation and Annual Festival will help
 enhance the living environment and financial state of the CDBG target area.

The City held a Community Outreach meeting on April 26, 2023 at the Latin American Association to solicit input into the development of the 2023 Action Plan. The public was invited via posting on the City's social media accounts. Forty-two emails seeking community input were sent to elementary, middle and high school principals, agency partners, Metro Fair Housing, DeKalb County Continuum of Care, DeKalb Housing Authority, Georgia Department of Community Affairs, Grady Medical — Brookhaven Urgent Care and local churches. This solicitation resulted in ten persons attending the outreach meeting. Their feedback will be invaluable as the City move forward with developing program descriptions and Request for Proposals (RFPs) to meet the needs of the community.

In addition, the public had the opportunity to comment or review the plan and comment at Public Hearings on Tuesday April 25 and Tuesday June 27, 2023, at 7:00 p.m. at the regular City of Brookhaven City Council Meeting. Announcements for public hearings and request for input were made at City

Council meetings, broadcast on Facebook and via Zoom, on April 11, April 25, and June 27, 2023. The final plan, including a summary of public comment, was adopted at the City of Brookhaven City Council Meeting on June 27, 2023.

Advertisements announcing availability of resources and public hearing dates in the <u>Champion Newspaper</u> and <u>Hispanico Mundo</u> are attached. Screen shots of the CDBG pages with further explanation and draft plan are also included as attachments.

5. Summary of public comments

No public comments were received on the Brookhaven 2023 Action Plan at the public hearing on April 25, 2023. During the Community Outreach Meeting on April 26, 2023 the attendees wanted to determine how their current activities would interact with the City's planned activities and following comments were received:

- Cross Keys Highschool noted the need for access to childcare for student parents and students
 that care for their siblings. A need for a pathway for early intervention for childcare before
 students drop out of school or miss days due to caring for children/siblings. Cross Keys has job
 training programs for their students that could parlay into workforce development programs
 that the City is seeking to develop. Cross Keys would be interested in providing input into how
 they can assist the City.
- We Love Buford Highway partnered with Peachtree Creek Greenway for a community outreach
 day. They found that the community was not aware that access to the Greenway was free and
 that there was a need for communication and clothing. The Greenway and We Love Buford
 Highway noted that they would need to think of inventive ways they can assist due to the
 nature of their organization being more informational.
- We Love Buford Highway has a Family Stability program that is an Orchestra Program that
 teaches children grades 3 through 8 how to play instruments. The orchestra fosters parent
 engagement and helps the children with leadership development. This program is an afterschool program that teaches the children a skill and provides parents with need after school
 care.

6. Summary of comments or views not accepted and the reasons for not accepting them

No comments were rejected.

7. Summary

On March 30, 2023, the City of Brookhaven advertised in the <u>The Champion Newspaper</u> and in <u>Mundo Hispanico</u> two public hearings to welcome the community to make comment on the 2023 CDBG Action Plan. Hearings were scheduled for April 25 and June 27, 2023. Written public comment closed June 9, 2023 and open comments were accepted on June 27, 2023.

The draft plan was posted to the City of Brookhaven CDBG website on May 11, updated on June 28, and made available at City Hall. Comments were welcome in-person, via phone, and via email at CDBG@BrookhavenGA.gov

Budget Summary and 2023 Project Listing

The City recognizes the importance of properly administrating the plan and setting a portion of funds aside annually for development of the 2026 Consolidated plans annually and recommends that 20% of the award be retained for Administration and Planning per HUD guidelines. Administration and Planning activities will include an Affordability Study of Apartment Rents to include outreach to residents and owners, The Analysis of Impediments to Affordable Housing as well as other eligible expenses. The remaining funds are available for priority activities. Staff recommendation, based on community input and HUD requirements are below:

1. Introduction

The 2023 Action Plan represents Brookhaven's third following extensive outreach for the 2021-25 Consolidated Plan. Throughout the year, the City engaged in outreach to solicit ongoing recommendations for the development of the 2023 Action Plan. City staff met regularly with the Salvation Army, Goodwill of North Georgia, the Center for Pan Asian Community Services, the Latin American Association, Los Vecinos du Buford Highway and We Love Buford Highway. Among our stakeholders there was strong support for moving forward with the Consolidated Plan. Our stakeholders were also instrumental in developing and using the plan to increase funding for Activities identified and funded in the 2023 Action Plan. Code Enforcement and Police Officers who meet regularly with low/mod income households advocated for funding for additional public safety outreach and continued targeted code enforcement and tenant education. Due to strong relationships between Code Enforcement and tenants residing in the Buford Highway Target Area, Code Enforcement was able to assist with communication between tenants and their landlord to facilitate cleanup of sewage back-up that impacted three units. Code Enforcement was able to assist with communication between the tenants and property management to facilitate cleanup within a two week period. Based on this input and staff recommendation for construction projects that will repair long-neglected infrastructure in the Buford Hwy Target Area the 2022 Action Plan was developed. Outreach included advertising of public meetings in English and in Spanish and posting of the proposed plan from May 11 through June 09, 2023, per the Citizen Participation plan.

Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I))

DeKalb County is charged with providing public and assisted housing, as well as governmental health and mental health services. The City continues to work with County staff and private agencies in order to provide aid where there were gaps.

DeKalb County does not operate public housing the City of Brookhaven. The City's participation in the Continuum of Care should provide additional opportunity to identify potential partnerships on housing as well as homelessness. While the housing authority has no public housing units in Brookhaven, they do support the residents living in assisted housing and those with housing choice vouchers. The family self- sufficiency (FSS) program is a voluntary program available to current housing choice voucher residents, which is designed to assist families in becoming independent of public assistance. The program includes case management services, and assists families with education, career counseling, job searches, mental and physical health issues, money management, childcare and other needs. The housing authority also supports homeownership opportunities through the Homeownership Voucher Program, which offers a mortgage subsidy for those who desire to purchase a home. Lastly, the Resident

Services Corporation (RSC) provides special programs and resident services that link the family to community-based service providers to help them become more stable in various areas of their lives.

The Brookhaven Police Department increased their mental health responder staff from 2 to 3 and remains dedicated to having a mental health responder on all calls, to de-escalate, evaluate, and direct patients to medical facilities rather than charge and/or arrest. The Department coordinates care with the Dekalb County and regional healthcare providers. Additionally, police officers' checks in weekly with the homeless population and coordinates with the Salvation Army for services as part of the City's homeless outreach.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

The City attended sessions in order to educate staff on the structure and county resources, specifically the DeKalb continuum of Care, and understanding its role in addressing needs in Brookhaven. Ongoing, staff attends their meetings and planning sessions in order to integrate Brookhaven needs and build partnerships into future strategies. During 2022 the City continued to work with agency partners, specifically Goodwill, the Salvation Army, the Latin American Association, and the Center for Pan Asian Community Services to identify families at risk of homeless and coordinate support. Brookhaven partners with the Salvation Army to provide outreach and connect homeless populations to housing, medical, and mental health services. In this process, every effort is made to identify veterans as connections are made. It is the experience thus far that families with children do not tend to shelter in Brookhaven however special care is taken to locate any families and connect to services. If services are declined, the City works to establish relationships, performs wellness checks and continues to offer connection to services. In both 2022 and 2023 Action Plan Activities, this program is formalized to provide data and accomplishments. During FY2022 Brookhaven Police Department (PD) joined cities nationwide for "America's Night Out Against Crime". The event was held in the Buford Highway Target Area. During this event, PD was able to interact with approximated 350 of the citizens who attended the event.

The City of Brookhaven does not receive ESG funds. That is a DeKalb County function however as Brookhaven staff is integrated into the Continuum of Care opportunities the City will access these resources controlled by the County.

1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

Throughout the year the City continued to have direct meetings with our supporting partner to solicit ongoing recommendations for the development of the 2023 Action Plan. City staff met or partnered with staff and volunteers at the Salvation Army, Goodwill of North Georgia, the Latin American Association, Los Vecinos de Buford Highway, and the Center for Pan Asian Community Services and made them aware of CDBG programs, plans and the need for community input. Additionally, the City held a Community Outreach meeting on April 26, 2023 at the Latin American Association to solicit input into the development of the 2023 Action Plan. The public was invited via posting on the City's social media accounts. Emails seeking community input were sent to Boys & Girls Clubs of Metro Atlanta, Center for Pan Asian Community Services, Cross Keys Sustainable Neighborhood Initiative, DeKalb County Continuum of Care, DeKalb School Grants & Partnerships, Druid Hills High School, Cross Keys High School, Chamblee High School, Chamblee Middle School, Druid Hills Middle School, Kittredge Magnet Middle School, Sequoyah Middle School, Elementary School, Ashford Park Elementary School, Briar Vista Elementary School, Cary Reynolds Elementary School, John Robert Lewis Elementary School, Montclair Elementary School, Montgomery Elementary School, Woodward Elementary School, PATH Academy (Charter) focused curriculum, Piedmont School of Atlanta (Oglethorpe Campus), DeKalb County Workforce Development, Georgia Department of Community Affairs, Goodwill of North Georgia, Grady Medical - Brookhaven Urgent Care, Housing Authority of Dekalb, Immigrant Hope Home, Independent Living Council of GA, Latin American Association, Los Vecinos du Buford Highway, Lynwood Park Foundation, Metro Fair Housing, Oglethorpe Presbyterian, Oglethorpe University, Peachtree Creek Greenway, Inc., Skyland UMC, Society of St. Vincent de Paul, The Salvation Army Temple Corps, and We Love Buford Highway. The City posted the budget and plan for over 30 days and held 2 public hearings as noted in the Community Outreach portion of the Action Plan. Plan Development and meetings were advertised in English speaking and Spanish speaking media.

Despite this outreach, the City received no public comments at the public hearings. The outreach meeting had an attendance of ten people. Comment for this meeting were discussed in detain in the Executive Summary and the City will utilize this input during program development and development of RFP. Stakeholders' participation with outreach increased and they have also continued to communicate directly with staff as strong relationships exist between our Community Development, Strategic Partnerships, and Community Outreach/Communications Departments and our service providers. City staff who coordinate regularly with supporting agencies reviewed the proposed budget and activities, made recommendations and shared as appropriate. Council twice reviewed the plan in light of their regular experience within the

Annual Action Plan

community. Constituents seemed satisfied with the outcome of the extensive outreach conducted for the 2021-25 Consolidated Plan and regular staff outreach. As a result, goal setting is consistent with the 2021 -2022 Action Plan and the 2021-25 Consolidated Plan.

Although participation increased from the prior year's level, a portion of the 2023 administrative funds will be directed towards increasing and receiving regular feedback on Activities and Outcomes in the 2023 Plan Year as it is anticipated that the balance of 2021 and 2022 Activities will be carried out in that timeframe. With increased staffing, the City anticipates that completion of activities and earlier, outreach will stimulate greater participation going forward.

The city anticipates receiving \$324,527 for the 2023 Action Plan and estimates receipt of \$360,000 annually through 2025.

identified Buford Highway Target area. Obstacles to addressing underserved needs are primarily communication and trust with our most vulnerable households. The City continues to utilize targeted code enforcement, education, and public safety outreach in order to repair and rebuild community trust.

The City of Brookhaven will target its scarce federal resources in low- and moderate-income neighborhoods in an effort to undertake comprehensive redevelopment activities that benefit residents and have lasting change.

Affordable Housing

AP-55 Affordable Housing – 91.220(g)

Introduction

The City of Brookhaven will continue to address affordable housing needs through supporting non-profit public service agencies that currently provide housing counseling services. Additionally, the city will directly support the renovation of up to 2 housing units through a residential renovation program and by partnering with other housing development organizations who are committed to improving Brookhaven's neighborhoods. The City anticipates that we will identify 2 households and begin work to qualify the households for residential renovations within the second half of fiscal year 2023. While Homeless needs are addressed through the County, Brookhaven continues to work with agencies, and across city lines to provide shelter and wrap-around services for homeless individuals.

Discussion

The city plans to continue its partnerships with area non-profit agencies to reduce homelessness and improve the lives of Brookhaven's low- and moderate-income residents. Through its targeted code enforcement, housing programs and partnerships, the city estimates 10 housing units will be improved. The City anticipates releasing a RFP in the 2023 program year.

The City's goal in the 2023 Action Plan is to provide services and resources to prevent homelessness and improve the quality of lower cost housing through enforcement and sustainable living environment.

AP-60 Public Housing – 91.220(h)

Introduction

The DeKalb County Public Housing Authority (PHA) is responsible for the administration of public housing and the housing choice voucher program. There are no public housing units in Brookhaven. Additionally, the PHA manages approximately 235 Housing Choice Vouchers within Brookhaven. The waiting list for vouchers is currently closed. The PHA is listed as troubled.

Actions planned during the next year to address the needs to public housing

While there is no Public Housing in Brookhaven, the City recognizes the need for increased vouchers or public housing opportunity and intends to meet with the PHA and Georgia Department of Community Affairs to advocate for investment and solutions.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

The DeKalb County Development Authority and its affiliate, **Resident Services Corporation (RSC)**, provide resident services and linkages to community-based service providers whom we partner with to provide social services and enrichment programs. Our overarching goal is to help individuals and families become more stable in various areas of their lives where they are having difficulty accessing or affording the support they need to be successful. Resident Services programs and activities focus on community engagement, economic growth and financial stability, health and well-being, and self-sufficiency opportunities for all residents.

The DeKalb Economic Development Authority, Decide DeKalb offers up to 3% down payment assistance to qualified home buyers. The Georgia Department of Community Affairs includes DeKalb County as a qualified location and offers up to \$10,000 in standard down payment assistance and administers additional programs offering up to \$12,500 to qualified buyers.

If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

City of Brookhaven CDBG funds are not sufficient to provide financial assistance to Dekalb Public Housing Authority. The City will work with the Authority to partner on education and services available to Brookhaven residents.

Discussion

There is great need for additional subsidized units in the City of Brookhaven to meet the needs of its most financially vulnerable residents. The costs to construct these units far exceeds the locally available

resources, particularly CDBG. The city and its housing partners will continue to seek federal programs and seek methods of encouraging affordable construction through ordinance.



AP-65 Homeless and Other Special Needs Activities – 91.220(i) Introduction

The DeKalb County Continuum of Care (CoC) coordinates homeless services and resources within DeKalb County. The City of Brookhaven will partner with the CoC to support area non- profit and faith-based agencies to deliver the needed and necessary services to the homeless and special needs populations.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The city will assist local agencies such as The Salvation Army, Latin American Association and Center for Pan Asian Community Services in their efforts to reduce homelessness and prevent families from entering homelessness.

A portion of these populations, such as elderly and physically disabled homeowners, may be assisted through the City's CDBG funded housing rehabilitation program. Outreach efforts are undertaken by a variety of agencies including the Brookhaven Police Department, who work with the individuals and link them with social service providers and services.

Addressing the emergency shelter and transitional housing needs of homeless persons

The city continues to coordinate with local agencies such as The Salvation Army, Latin American Association and Center for Pan Asian Community Services in their efforts to reduce homelessness and link homeless families with shelter through the Continuum of Care coordinated entry system.

Unsheltered homeless residents are connected to the necessary shelter, clothing and food resources within the community through the efforts of the Brookhaven Police Department Community Program.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The city will coordinate with Continuum of Care partner agencies to link homeless families find and

obtain appropriate permanent housing within DeKalb County. Further, the Brookhaven Police Department is in a coordinated program with the Salvation Army to provide outreach to homeless individuals. The City Code Enforcement Department identifies homeless individuals and makes contact when able. Information is transferred to the Police Department Community Outreach services for referral. Efforts are made to contact the individual to assess need and connect to services. In addition, the Outreach Officer meets regularly with the Salvation Army to report on success/failure to connect. As part of the 2023 Action Plan, the City is providing the Salvation Army homeless day program with a laptop so that a case worker can more easily and quickly connect homeless to appropriate/available services. Homeless residents are connected to the appropriate housing through the DeKalb County coordinated entry system.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

The city will support it's nonprofit and faith-based partners in their efforts to reduce homelessness and prevent families from entering homelessness. Local agencies have identified the need for life skills and job training so that clients can avoid a housing crisis in the future. While resources are scarce, Brookhaven is working with the growing healthcare industry in Brookhaven, the Latin American Association, and the Salvation Army to identify the best use of resources for training that will lead to improved wages and/or job stability. Additionally, the childcare benefits in the 2023 Action plan and the balance of the 2021 and 2022 Action plans will be targeted to our most at risk households in order to significantly decrease monthly costs and allow heads of households to work or receive additional job training during and after school hours without a significant increase in expenses.

Discussion

The City the Brookhaven will continue to support public agencies with CDBG funds to reduce the effects of homelessness and transition homeless individuals into permeant supportive housing. Staff will continue to participate in the DeKalb County Continuum of Care to help ensure a coordinated approach between public agencies and the Consolidated Plan activities.

AP-75 Barriers to affordable housing – 91.220(j)

Introduction:

Over the years, the City of Brookhaven has attempted to eliminate barriers to affordable housing and residential investment. These efforts included amending the zoning code to allow smaller lot development and requiring affordable housing units in developments greater than 10 units.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The city is committed to removing regulatory barriers to affordable housing. As previously discussed, the city has made great strides in that effort. Additionally, the City commits to continue:

- To provide fair housing enforcement and education outreach
- Annually examine its policies for unintended barriers to affordable housing
- Educate residents on the affordable housing needs within Brookhaven
- Evaluate surplus land that may be used for affordable housing development
- Evaluate tax incentives for new affordable housing

Discussion:

The largest barriers for affordable housing and residential investment are the funding gap to cover the relatively high cost of land and construction, versus the lower sales price or rents that residents can afford. The need for quality affordable housing in Brookhaven far exceeds the community's resources. To that end, the city will continue to work with its partners to acquire external resources necessary to make incremental neighborhood improvements, and the city will continue to strategically invest in housing and community projects that improve the lives of its low- and moderate-income residents.

AP-85 Other Actions – 91.220(k)

Introduction:

Below are additional actions the city will continue undertaking to improve Brookhaven's neighborhoods.

Actions planned to address obstacles to meeting underserved needs

The City will monitor expiring Section 8 contracts and initiate dialogs with those property owners well in advance of the contracts expiring. Additionally, there are planned activities to address mobility challenges, deteriorating properties, and support aging in place through home renovation.

Actions planned to foster and maintain affordable housing

As described in the Consolidated Plan, there are privately owned, subsidized apartment developments that are nearing the end of their Section 8 contracts or LIHTC compliance period. The City will reach out to the property owners and see what assistance may be necessary to keep the units within the affordable housing inventory. The City will also monitor expiring Section 8 contracts and initiate dialogs with those property owners well in advance of the contracts expiring.

Actions planned to reduce lead-based paint hazards

The City will address lead-based paint hazards in properties that receive CDBG funds. Additionally, the city will identify neighborhoods where children could be at high risk for lead poisoning and provide education and outreach to those families. The city will also seek additional funding to remove lead-based paint hazards in units with young children and expand the inventory of lead safe housing units.

Actions planned to reduce the number of poverty-level families

The City of Brookhaven has a multi-pronged anti-poverty strategy. The first component is to address the affordability of housing in the community; the second is to support social service agencies providing services to Brookhaven; and the third is providing support to educational and job training programs targeted to low-income residents.

HOUSING

Housing in Brookhaven is unaffordable to extremely-low- and very-low-income residents. The city will partner with agencies to provide a series of programs designed to assist residents who are ready to purchase a home, renovate their current home, or find and maintain affordable rental housing. The city will partner with housing developers to bring additional affordable housing units online and improve the

quality of existing units.

SOCIAL SERVICES

The city will work with local partner agencies to address social services needs for the community. This assistance, whether in direct financial assistance, case management, or education, will help low- and moderate-income clients improve their living conditions and make changes to their situation that will hopefully lead them out of poverty.

JOB TRAINING AND EDUCATION

As outlined in the Consolidated Plan and funded in the 2021 Action Plan, the City will aggressively seek to design and implement workforce development and employment training programs. The City plans to work with the local high schools, non-profit agencies and businesses to develop these programs. Activities developed will help provide the skills and education necessary for clients to obtain the types of skilled employment that can provide higher wages than existing low-wage unskilled jobs.

Actions planned to develop institutional structure

The Community Development Department is charged with planning, administering, and completion of the CDBG funded projects. The Department works very closely with local partner agencies to undertake the many projects and priorities of the community. The city could not complete these tasks alone and relies on community support to meet the goals and objectives of the Consolidated Plan and the CDBG program. In 2023 administrative funds will be available to allow staffing to implement both the 2022 and 2023 Action plans.

An identified gap in the institutional structure is the efficient and complete dissemination of information to the public about programs, activities and opportunities. During 2022, the city and its partners were able to improve the access to information, to ensure that residents are aware of the programs and services available to them as they work to improve their lives and neighborhoods. Throughout 2023 we will continue seeking and implementing innovative ways of disseminating information to our citizens.

Actions planned to enhance coordination between public and private housing and social service agencies

The city will continue to improve its coordination between public and private housing and social service agencies. The city will use existing processes, such as the Continuum of Care and regional economic development forums, to coordinate among the various public and private agencies, companies and organizations. These efforts should help with ongoing coordination and reduce the likelihood of

organizations and partners working at cross purposes.

Discussion:

The city is committed to improving the housing and economic situation of Brookhaven's residents, business owners, and neighborhoods. Through deliberate and intentional actions, the city will work to reduce barriers to affordable housing, increase wealth for low-and moderate-income households, and ensure its residents have access to information about the programs and services available to improve their lives. These actions, coupled with the programs and activities outlined in this Action Plan will lay the foundation for creating neighborhoods of choice, and improving the health of families and communities.

On or about June 29, 2022, the City of Brookhaven intends to submit the following substantial amendment to the U.S. Department of Housing and Urban Development (HUD) for its FY2021 Annual Action Plan.

Activity 6: Neighborhood Facilities Improvements budgeted \$59,803 for reduction of environmental hazards including improvements to publicly accessible neighborhood facilities such as parks, recreation centers or non-profit facilities. The initial targeted activity of funding, removal of asbestos in a publicly accessible community center, was achieved through other funding sources, requiring reallocation of these funds. Activity 6 also considers support of lead-safe housing units. This category is removed from the FY2021 Action Plan however will remain in the 5-year consolidated plan.

Per this amendment \$59,803 will be reallocated exclusively to Activity 5: ADA sidewalk improvements including sidewalk reconstruction and ADA compliant curb ramps. Improvements will be concentrated in the Buford Highway corridor area however eligible activities may occur in areas immediately adjacent to the target area in order to support connectivity for target area residents.

This amendment supports CDBG approved goals, addresses significant need identified in the Brookhaven Consolidated Plan and supports the United States Department of Housing and Urban Development's timeliness rule in accordance with 24 CFR 570.902


