



#### **LEGAL DESCRIPTION**

ALL THAT TRACT or parcel of land lying and being in Land Lot 236 of the 18<sup>th</sup> Land District, Dekalb County, Georgia, being known as Lot 7, Block D of the Wawona Forest subdivision, being more particularly described as follows:
