Unless otherwise directed, all work performed shall be in accordance with the Georgia Department of Transportation *Standard Specifications, Construction of Transportation Systems* (current edition). All materials used in the process of completion of the work included in the Contract will be furnished from Georgia Department of Transportation certified suppliers only.

It is the intent of this Bid to include all items of construction and all Work called for in the Specifications, or otherwise a part of the Contract Documents.

In accordance with the foregoing, the undersigned proposes to furnish and construct the items listed in the attached Bid schedule for the unit prices stated.

BONDING REQUIREMENTS

Each bid must be accompanied with a BID BOND (bond only: certified checks or other forms are not acceptable) in an amount equal to five percent (5%) of the base bid, payable to the City of Brookhaven. Said bid bond guarantees the bidder will enter into a contract to construct the project strictly within the terms and conditions stated in this bid and in the bidding and contract documents, should the construction contract be awarded.

The Successful Bidder shall be required to furnish a bond for the faithful performance on the contract and a bond to secure payment of all claims for materials furnished and/or labor performed in performance of the project, both in amounts equal to one hundred percent (100%) of the contract price.

Bonds shall be issued by a corporate surety appearing on the Treasury Department's most current list (Circular 570 as amended) and be authorized to do business in the State of Georgia.

SPECIFICATIONS

Complete renovation of six (6) tennis courts located at the Blackburn Tennis Center; 3501 Ashford Dunwoody Rd., Brookhaven, GA 30319.

The bid is for the complete tear down and renovation of six (6) tennis courts, including adjacent landscaping, fencing and quick stat lines on courts #1, 2, 3, 4, 5 & 6. (See attached map on page 16).

All six (6) tennis courts may be under construction simultaneously.

Specs for construction:

- Tennis Court Surface
 - All six (6) courts shall have a surface of a standard hard court.
 - Tennis court lines (copy existing color) shall be replaced on each court, as well as QS lines (blue) shall be added to the surface.
- Landscaping
 - o Landscaping shall be returned to its current state/improved during construction.
 - o This may include:
 - Creating a landscape and tree plan that meets the City's approval.
 - Removal/installation of trees.
 - Removal/installation of sod/grass.
 - Removal/installation of flowers/plants.
- Fencing
 - All court fencing shall be returned to its current state.
 - No additional fencing is required.
- Amenities
 - Other items on the court and surrounding landscape shall be put back to its original location unless otherwise directed.
 - These items include: score boards, ball holders, benches, chairs, nets, poles etc.
