8. In what format are you interested in receiving cost proposals? The table of Contents refers to an Appendix A Cost Proposal, but none is included in the document. **Please see below**
9. Other than an encroachment permit, is there any additional GDOT involvement with the project? **Please read the scope about coordination with GDOT on two other projects in the same area.**

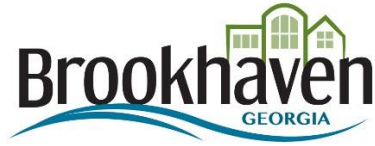
