Invitation to Bid (ITB) shall be presented in a sealed opaque envelope with the bid number and name ITB 18-151 Stratfield Drive Drainage Improvements Project - Phase 1clearly marked on the outside of the envelope. The name of the company or firm submitting a bid should also be clearly marked on the outside of the envelope. ONE (1) ORIGINAL PAPER COPY AND ONE DISK/FLASH DRIVE OF THE BID MUST BE SUBMITTED.

SCOPE OF SERVICES

The Contractor shall provide the necessary machinery, tools, apparatus, other means of construction, and all materials and labor specified in the Contract Documents or as necessary to complete the City of Brookhaven Project Stratfield Drive Drainage Improvements Project – Phase 1, as per the attached layouts and descriptions.

Unless otherwise directed, all work performed shall be in accordance with the Georgia Department of Transportation *Standard Specifications, Construction of Transportation Systems* (current edition). All materials used in the process of completion of the work included in the Contract will be furnished from Georgia Department of Transportation certified suppliers only.

There are no materials or equipment provided by the City of Brookhaven as part of this Contract.

Stratfield Drive Drainage Improvements Project - Phase 1

PROJECT DESCRIPTION

The purpose of the Stratfield Drive Drainage Improvements Project – Phase 1 is to relieve drainage issues along the entire length of the project, as well as replace existing storm pipe which consists of dissimilar materials and inadequate sizes. The overall project extent is shown as Exhibit B. The project is divided into three phases, with the scope of this ITB encompassing only Phase 1. A Stormwater Analysis Report was completed September 22, 2016 which outlined recommendations for addressing the flooding issues in the northernmost area. Subsequent hydrologic analysis modeled the appropriate downstream pipe sizing to tie in to the existing pipes which discharge into unnamed circle. Construction drawings for the recommendations were approved by the City of Brookhaven on May 1, 2018.

SCOPE OF SERVICES

This ITB for Stratfield Drive Drainage Improvements Project – Phase 1 will encompass only the project extent as shown in the construction drawings.

The Contractor shall provide the necessary machinery, tools, apparatus, other means of construction, and all materials and labor specified in the Contract Documents or as necessary to complete the Stratfield Drive Drainage Improvements Project – Phase 1, as per the attached layouts and descriptions.

Unless otherwise directed, all work performed shall be in accordance with the Georgia Department of Transportation *Standard Specifications, Construction of Transportation Systems* (current edition). All materials used in the process of completion of the work included in the Contract will be furnished from Georgia Department of Transportation certified suppliers only.

There are no materials or equipment provided by the City of Brookhaven as part of this Contract.

Required Work:

- 1. Remove four (4) existing drain pipes for Phase 1 as described in attached drawings.
- 2. Install four (4) new drain pipes meeting pipe specifications indicated on the attached drawings.

- 3. Contractor shall coordinate with Dekalb County prior to construction activities verify existing water lines and sanitary sewer lines in the project area to ensure there is no interruption to county sanitary service or water services to residents. Existing sanitary sewer lines were surveyed and are shown on the Existing Conditions Plan, but may not show the full extent of sanitary sewer lines in the area.
- 4. Contractor shall coordinate with other utility companies with service in the construction area as identified by a calling 811 (Georgia Utilities Protection Center) for utility location and marking requested by the contractor.
- 5. Contractor will manage work during construction to allow continued traffic flow on Ragley Hall Drive and Epping Forest Drive. Contractor will be responsible to direct traffic around construction in a controlled manner.
- 6. Contractor will obtain a right-of-way encroachment permit for any disturbance within the rightof-way. The permit can be obtained by going online to <u>http://brookhaven.ga.roway.net/</u> and registering as a user, and then submitting the right-of-way encroachment permit application through the site.
- 7. Contractor will ensure that road surfaces affected by this project will be restored to existing conditions as indicated in the construction drawings.
- 8. Contractor will ensure that private driveways affected by this project will be restored to existing conditions as required by Dekalb County STD 709 which is shown on the Storm Details Drawing.
- 9. The contractor is responsible for calling for utility locations prior to the start of the project. It shall be the contractor's responsibility to coordinate his work with any utility owner whom maybe in conflict with his work. No claims will be considered for extra compensation.
- 10. Any item which must be removed during the construction work and is not specially called for shall be removed by the contractor. The cost shall be included in the unit cost for the bid items. No claims will be considered for extra compensation.
- 11. It is the intent of this contract for each unit price bid to include all labor, materials, equipment, tools, transportation, and supplies as required as necessary to complete the work in accordance with the plans, specifications as directed, and the terms of this contract. No additional unit costs shall be allowed for clearing, grubbing and/or grading activities.
- 12. All clearing, grubbing and/or grading activities shall be included in the unit cost for other items requested.
- 13. The general descriptions of each item of work are as described in the Georgia Department of Transportation's standards and specifications, complete and accepted. Any conflicts which might occur during the course of the construction work or any conflicts which might be related to the compensation of any work shall be decided based on the Georgia DOT's standards and specifications. No claims will be considered for extra compensation.
- 14. Upon the completion of each project, any excess items which might be left over from the construction related work shall be removed and disposed of properly by the contractor. The cost for such removal and disposal of such items will be included in the project bid items. No claims will be considered for extra compensation.
- 15. Under this scope, "Department", "Engineer", and "Resident Engineer" shall mean the "City of Brookhaven, Georgia, Public Works Director or Public Works Designee".
- 16. Working hours are expected to be Monday through Friday, 8:00 A.M. to 7:00 P.M. except where otherwise noted. Lane closures are limited to the hours of 9:00 A.M to 4:00 P.M. No work is permitted on city-observed holidays.
- 17. Contractor shall have all vehicles marked with their company name.

- 18. The contractor will participate in one overall contract pre-construction meeting at Brookhaven City Hall shortly after award of the contract and other meetings as required. The City may at its discretion require meetings between the contractor superintendent and the Engineer to be held once a week with two-week schedule look-a heads or additional meetings to ensure project execution.
- 19. The contractor will provide video and pictures of the project area before the project begins and after the project is complete. The video and pictures will be provided to the City once it is complete in an acceptable format.
- 20. Type B Handicap Ramp installation shall be included as a part of the sidewalk pay item. This is an addition which is not shown on the construction drawings, but is included in the Table of Quantities.
- 21. Sidewalk to be removed along Ragley Hall Road will consist of removal of the existing 4-foot sidewalk beginning at the driveway of 1511 Ragley Hall Road and replacement with new 5-foot sidewalk to the new Type B Handicap Ramp where it will terminate. Type B Handicap Ramp will occur at the southernmost intersection of Ragley Hall Road and Epping Forest Drive.
- 22. Sidewalk to be removed along Epping Forest Drive will consist of the removal of the existing 4-foot sidewalk beginning at the driveway of 1464 Epping Forest Drive and replacement with new 5-foot sidewalk to the point where the southernmost property line of 1464 Epping Forest Drive would intersect with the sidewalk. For reference on the construction drawings, the pipe between structure J6 and A1 is centered on the property line. Gradual transition from new 5-foot to existing 4-foot sidewalk will occur over an 8-foot distance.
- 23. The City of Brookhaven will not provide restroom facilities.
- 24. The Contract shall perform project housekeeping/clean-up on a daily basis. A 24-hour contact must be provided to the City of Brookhaven Call Center for all issues as needed in regards to the project for any safety, signage, erosion control, or other emergency as needed.
- 25. The Contractor's performance will be measured based on the following:
 - a. Compliance with the Scope of Work
 - b. Meeting the agreed upon schedule dates
 - c. Submission of all deliverables as specified

Time and Liquidated Damages

The Contractor shall not proceed to furnish such services and the City shall not become obligated to pay for same until a written authorization to proceed ("Notice to Proceed") has been sent to the Contractor from the City. The Contractor shall commence the Work no later than ten (10) days after the effective date of the Notice to Proceed and shall achieve Substantial Completion of the Work, as hereinafter defined, no later than 75 calendar days, in accordance with the Contract Documents. The number of calendar days from the date on which the Work is permitted to proceed, through the date set forth for Substantial Completion, shall constitute the Contract Time. The Work shall be carried on expeditiously, it being understood, however, that this Agreement may be extended or continued in force by the parties hereto in writing as provided herein.

The Contractor shall pay the City the sum of \$500.00 per day for each and every calendar day of unexcused delay in achieving Substantial Completion beyond the date set forth herein for Substantial Completion of the Work. Any sums due and payable hereunder by the Contractor shall be payable, not as a penalty, but as liquidated damages representing an estimate of delay damages likely to be sustained by the City, estimated at or before the time of executing this Contract. When the City reasonably believes that Substantial Completion will be inexcusably delayed, the City shall be entitled, but not

required, to withhold from any amounts otherwise due the Contractor an amount then believed by the City to be adequate to recover liquidated damages applicable to such delays. If and when the Contractor overcomes the delay in achieving Substantial Completion, or any part thereof, for which the City has withheld payment, the City shall promptly release to the Contractor those funds withheld, but no longer applicable, as liquidated damages.

Substantial Completion

Substantial Completion shall mean that stage in the progression of the Work when the Work is sufficiently complete in accordance with this Contract that the City can enjoy beneficial use and occupancy of the Work and can utilize the Work for its intended purpose. Partial use or occupancy of the Project shall not result in the Project being deemed substantially complete, and such partial use or occupancy shall not be evidence of Substantial Completion.

Time is of the Essence

All limitations of time set forth in the Contract Documents are of the essence of this Contract.

This bid will require bonds. Please see bonding documents at the end of this procurement.

INSURANCE REQUIREMENTS

Within 10 days of Notice of Award, and at all times that this Contract is in force, the Contractor shall obtain, maintain and furnish the City Certificates of Insurance from licensed companies doing business in the State of Georgia with an A.M. Best Rating A-10 or higher and acceptable to the City covering:

- 1. Workers' Compensation & Employer's Liability Insurance. Workers' Compensation Insurance in compliance with the applicable Workers' Compensation Act(s) of the state(s) wherein the work is to be performed or where jurisdiction could apply in amounts required by statutes. Employer's Liability Insurance, with limits of liability of not less than \$1,000,000 per accident for bodily injury or disease.
- 2. Commercial General Liability Insurance, including contractual liability insurance, product and completed operations, personal and advertising injury, and any other type of liability for which this Contract applies with limits of liability of not less than \$1,000,000 each occurrence / \$2,000,000 policy aggregate for personal injury, bodily injury, and property damage. Commercial General Liability Insurance shall be written on an "occurrence" form.
- 3. Automobile Liability Insurance with limits of liability of not less than \$1,000,000 per accident for bodily injury and property damage if automobiles are to be used in the delivery of or in the completion of services and work or driven onto the City's property. Insurance shall include all owned, non-owned and hired vehicle liability.
- 4. Umbrella Insurance with limits of liability excess of Employer's Liability Insurance, Commercial General Liability Insurance and Automobile Liability Insurance in the amount of not less than \$3,000,000.
- Contractors' Pollution Legal Liability and/or Asbestos Legal Liability and/or Errors and Omissions (if project involves environmental hazards) with limits not less than \$1,000,000 per occurrence or claim, and \$2,000,000 policy aggregate.
- 6. Professional (Errors and Omissions) Insurance- For Professional Services and for all Design/Build Projects with limits of liability of not less than \$3,000,000 per occurrence or claim / \$3,000,000 policy aggregate. Such policy shall also include coverage for losses arising from the breach of information security or cyber liability (including Errors & Omissions, Security and Privacy Liability and Media Liability), whether combined with the Professional Liability policy or placed as a separate policy, but carrying the same limits of liability. Such coverage shall insure damage, injury and loss caused by error, omission or negligent acts, including all prior acts without limitation, related to the professional services to be provided under this Contract. The policy shall be amended to include independent contractors providing professional services on behalf of or at the direction of the Contractor. The definition of Contractual Liability shall be amended to state that liability under a contract of professional services is covered. Further, coverage shall be afforded for fraudulent acts, misappropriation of trade secrets, internet professional services, computer attacks, personal injury, regulatory actions, wrongful acts, contractual liability, privacy policy, and insured versus insured. The Contractor shall ensure that coverage under this policy continues for a period of thirty-six (36)

months after completion of services.

7. Fidelity Bond (Employee Dishonesty) in the sum of not less than \$50,000.

All such insurance shall remain in effect until final payment is made and the Project is accepted by the City. If the Contractor receives notice of non-renewal or material adverse change of any of the required coverages, the Contractor shall promptly advise the City in writing. Failure of the Contractor to promptly notify the City on non-renewal or material adverse change of any of the required coverages terminates the Agreement as of the date that the Contractor should have given notification to the City. The insurance policies shall contain or be endorsed to contain, the following provisions:

A provision that coverage afforded under such policies shall not expire, be canceled or altered without at least thirty (30) days prior written notice to the City.

Workers' Compensation and Employer's Liability and Property insurance policies shall contain a waiver of subrogation in favor of the City and the City's boards, officials, directors, officers, employees, representatives, agents, and volunteers.

Commercial General Liability, Automobile Liability Contractors' Pollution Legal Liability and/or Asbestos Legal Liability and/or Errors and Omissions (if project involves environmental hazards) insurance policies shall include an endorsement making the City and the City's boards, officials, directors, officers, employees, representatives, agents, and volunteers Additional Insureds under such policies.

A copy of these endorsements shall be provided to the City.

Certificates of Insurance showing that such coverage is in force shall be filed under this Contract by the Contractor to the City.

The obligations for the Contractor to procure and maintain insurance shall not be construed to waive or restrict other obligations and it is understood that insurance in no way limits liability of the Contractor whether or not same is covered by insurance.

BONDING REQUIREMENTS

Each bid must be accompanied with a BID BOND (bond only: certified checks or other forms are not acceptable) in an amount equal to five percent (5%) of the base bid, payable to the City of Brookhaven. Said bid bond guarantees the bidder will enter into a contract to construct the project strictly within the terms and conditions stated in this bid and in the bidding and contract documents, should the construction contract be awarded.

The Successful Bidder shall be required to furnish a bond for the faithful performance on the contract and a bond to secure payment of all claims for materials furnished and/or labor performed in performance of the project, both in amounts equal to one hundred percent (100%) of the contract price.

The Successful Bidder shall also be required to furnish a Maintenance Bond, in the amount of one-third (1/3) of the contract price, guaranteeing the repair or replacement caused by defective workmanship or materials for a period of one (1) year from the completion of construction.

Bonds shall be issued by a corporate surety appearing on the Treasury Department's most current list (Circular 570 as amended) and be authorized to do business in the State of Georgia.

Date of Bond must not be prior to date of Contract. If Contractor is a Partnership, all partners shall execute Bond.
