AN ORDINANCE TO AMEND THE STREET LIGHTING FUND BUDGET FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021 FOR THE CITY OF BROOKHAVEN PURSUANT TO ARTICLE V OF THE CITY OF BROOKHAVEN CHARTER, APPROPRIATING AN AMOUNT OF \$21,406.10 FROM THE STREET LIGHTING RESERVE BALANCE FOR THE CAPITAL COST ASSOCIATED WITH THE DRESDEN DRIVE STREET LIGHTS LED CONVERSION, ALLOWING THE FINANCE DEPARTMENT TO MAKE TECHNICAL CHANGES AS NECESSARY, AND PROHIBITING EXPENDITURES FROM EXCEEDING ACTUAL FUNDING SOURCES, AND FOR OTHER PURPOSES

WHEREAS, the Official Code of Georgia Annotated, Chapter 36, Section 81, Subsection 3, requires that each local government adopt a balanced budget for all required funds; and

WHEREAS, the Official Code of Georgia Annotated, Chapter 36, Section 81, Subsection 3, Paragraph (d) allows a local government to amend its budget to adapt to changing governmental needs during the budget period; and

WHEREAS, Dresden Drive has 36 streetlights with various wattage depending on location and area coverage; and

WHEREAS, Georgia Power has presented the City of Brookhaven with an opportunity to replace the existing lighting on Dresden Drive with LED lights for an amount of \$21,406.10 with projected future annual electric bill savings of \$3,002.88; and


WHEREAS, the City of Brookhaven maintains balanced budgets, such that anticipated funding sources equal or exceed the proposed expenditures.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BROOKHAVEN HEREBY ORDAINS, AS FOLLOWS:


1. The amendment of the budget of the City of Brookhaven for the appropriation of FY 2021, Street Lighting Reserve Fund balance for the capital cost associated with the Dresden Drive street lights LED conversion is hereby approved.
2. The City Council authorizes the City Manager or his designee to take any action necessary to complete this ordinance.
3. Should any section of this ordinance be declared invalid or unconstitutional by any court of competent jurisdiction, such declaration shall not affect the validity of the resolution as a whole or any part thereof which is not specifically declared to be invalid or unconstitutional.

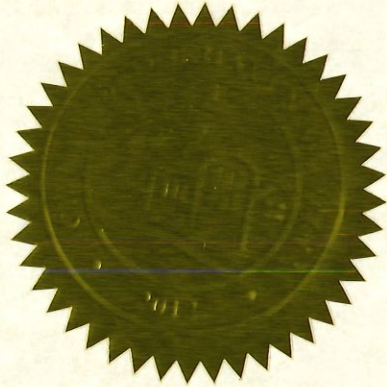


