

IWQ 15-02 Informal Request for Qualifications Tennis Court Resurfacing

DUE Thursday, March 19, 2015 at 2:00pm

The City is seeking bids to resurface ten (10) tennis courts at five locations. There are two tennis courts at each location. The addresses of each location are below on the bid form. The scope of the work for each tennis court is as follows:

- 1. Clean courts as necessary.
- 2. Fill all structural cracks with E330 crack filler and install multi layered rite way crack repair system over all structural cracks (1/16" or larger.) The rite way product will not bubble, has no hollow sound and incorporates a micro sealant moisture barrier over the cracks.
- 3. Install fiberglass membrane on hairline cracks.
- 4. Patch cracks on bottom of fencing with acrylic patch binder.
- 5. Fill all low lying areas and paving joints with acrylic patch binder NOTE: These areas will improve but will not be perfect.
- 6. Apply 3 coats of Deco Full Acrylic Playing surface. (Note: This is the manufacturer of the tennis court acrylics of the U.S. Open. If Deco is out of stock, we will use a brand that is equal in quality to Deco (colors to be selected by owner.)
- 7. Stripe 4 regulation tennis courts with one coat of primer and two coats of texturized white line paint.
- 8. Sand and paint net posts, re-hang new nets and clean work site thoroughly.

The City strongly encourages any vendor making a proposal to visit each of the locations to better identify the cost associated with the repairs. The City will not be having a pre-bid meeting or site visits.

All questions will be gathered and an addendum answering all questions will be issued shortly thereafter. Questions will only be accepted via email. No questions will be answered by phone to ensure the same information is given to all bidders. When awarded, the announcement will be made on the City's Purchasing Page, and the winning bidder will be contacted directly. Candidates may or may not be contacted for further information.
