SPECIFICATIONS

Project Description

A survey assessment of the 3 bathhouses was conducted to identify all areas needing repairs upgrades, renovations, replacement and/or additions. Described below are each Bathhouse and components of the project. The City is requesting that qualified general contractors review the description and specifications for the Bathhouses and develop a quote for each Bathhouse to complete the projects as described.

1.0 Lynnwood Bathhouse

General conditions, needed repairs and upgrades.

- **1.01** Exterior split-face block with metal roof is in good condition. Approximate building size 75' x 24' (1,800 sq. ft.).
- a. Pressure spray exterior block removing dirt, stains and mold.
- b. Pressure spray entrance/exit hallway floors to clean.
- c. Repair damaged wall and shower fixture on outside showers.
- **1.02** Bathhouse Office 11.5' x 14.5' (167 sq. ft.)
- a. Remove existing counter/cabinet.
- b. Design/build "L" shaped composite counter top approximately 18 linear feet by 1.5' transitioning to and serving as 2 customer service windows. Counter to include storage cabinets, drawers and shelves. City to approach final design before construction.
- c. Repair any minor plywood ceiling disrepairs.
- d. Replace ceiling fan and light fixtures with safety lens covered lights.
- e. Pressure spray clean floor.
- f. Prepare walls, ceiling and doors for receiving Kilz primer.
- g. Paint ceiling and walls with Sherwin-Williams Sher-Color Exterior Architectural, A-100 Latex Gloss Extra White Custom Manual Match code:

CCE*Colorant 02. 32. 64. 128 1/3 - Deep Gold - 2 - 1

- h. Paint metal doors and window frames after Kilz primer, (finish color to match existing color) using same Sherwin-Williams Sher-Color Exterior Architectural paint.
- i. Repair/replace two (2) sliding glass windows approximately 32" x 42".
- **1.03** Men's and Women's Bath, both approximately 11.5' x 14.5' (167 sq. ft. each).
- a. Repair any minor plywood ceiling disrepairs.
- b. Pressure spray clean tile floors to restore.
- c. Repair to hide abandon plumbing in Women's Bath common wall with outside showers.
- d. Paint walls and ceiling as previously specified in this document.

1.04 Exterior Metal Doors

- a. Repair/replace double metal doors and frame on Storage Room and Filter Room.
- b. Paint all doors and frame to match existing color with Sherwin-Williams Sher-Color Exterior Architectural as specified in this document.

1.05 Filter Room

- a. Replace electrical panel in filter room.
- b. Replace light fixtures new with safety lens covered lights.
