## **INSURANCE REQUIREMENTS**

Within 10 days of Notice of Award, and at all times that this Contract is in force, the Contractor shall obtain, maintain and furnish the City Certificates of Insurance from licensed companies doing business in the State of Georgia with an A.M. Best Rating A-6 or higher and acceptable to the City covering:

Any separate insurance maintained in force by the additional insured named above shall not contribute to the insurance extended by Contractor's insurer(s) under this additional insured provision.

## **BONDING REQUIREMENTS**

Each bid must be accompanied with a BID BOND (bond only: certified checks or other forms are not acceptable) in an amount equal to five percent (5%) of the base bid, payable to the City of Brookhaven. Said bid bond guarantees the bidder will enter into a contract to construct the project strictly within the terms and conditions stated in this bid and in the bidding and contract documents, should the construction contract be awarded.

The Successful Bidder shall be required to furnish a bond for the faithful performance on the contract and a bond to secure payment of all claims for materials furnished and/or labor performed in performance of the project, both in amounts equal to one hundred percent (100%) of the contract price.

Bonds shall be issued by a corporate surety appearing on the Treasury Department's most current list (Circular 570 as amended) and be authorized to do business in the State of Georgia.

## SPECIFICATIONS

### Project Description

#### **MURPHY CANDLER BATH HOUSE**

General conditions, needed repairs and upgrades.

Exterior split-face block with metal roof is in good condition. Approximate building size 93' x 25' (2,325 sq. ft.).

- a. Prepare breezeway entrance/exit walk to receive re-coating epoxy type floor composite to match existing coating. Area 24' x 6' (144 sq. ft.).
- b. Pressure spray clean block and soffit of dirt, stains and mold.
- c. Repair lock/handle on Mechanical Room.
- d. Prepare and paint all medal exterior doors and frames to match existing color as with specified primer and paint in this document (Kilz primer/Sherwin-Williams Sher-Color).

Bathroom Office approximately 17' x 14' (238 sq. ft.).

- a. Remove existing counter/cabinet.
- b. Design/build "L" shaped composite counter top approximately 18 linear feet by 1.5' transitioning to and serving as 2 customer service windows. Counter to include storage cabinets, drawers and shelves. City to approach final design before construction.
- c. Repair any minor plywood ceiling disrepairs.
- d. Replace ceiling fan and light fixtures with safety lens covered lights.
- e. Pressure spray clean floor.
- f. Prepare walls, ceiling and doors for receiving Kilz primer.
- g. Paint ceiling and walls with Sherwin-Williams Sher-Color Exterior Architectural, A-100 Latex Gloss - Extra White.

Large Storage Room off of Office approximately 22' x 22' (484 sq. ft.).

- a. Repair any minor plywood ceiling disrepairs.
- b. Pressure spray clean floor.
- c. Paint ceiling and walls with Sherwin-Williams Sher-Color Exterior Architectural, A-100 Latex Gloss - Extra White.

Men's and Women's Bath both 28' x 10.5' (294 sq. ft. each).

- a. Remove stainless steel trough urinal and supply and install 2 standard mounted units at standard height.
- b. Furnish and install polymer partition between urinals matching color of existing toilet partitions.
- c. Fabricate 6 - 5' x 9.5" polymer benches using the same material and color of the partitions. Seat top should be 19" high. Use aluminum angle brackets with stainless steel fasteners for pedestal supports. Note: See Attachment 1 for picture examples.
- d. Furnish and install clothes hooks in Women's Bath to match clothes hooks system in Men's Bath.
- e. Pressure spray clean floor tile to restore to "like new" condition.
- f. Patch/repair cinder block wall in Women's Bath where water line break repair.
- g. Repair all vinyl wall panels.
- h. Replace all light fixtures new with safety lens covers.
- l. Investigate and make remedial plumbing repairs to outdoor shower fixtures to become operational from inside women's bath

Men's/Women's Bathroom off of pool deck, approximately 6' x 6.5' (39 sq. ft.).

- a. Pressure spray clean floor tile to restore to "like new" condition.
- b. Prepare ceiling and walls to receive Kilz primer.



c. Paint ceiling and walls with Sherwin-Williams Sher-Color Exterior Architectural, A-100 Latex Gloss - Extra White.

Mechanical Room 11' x 9' (100 sq. ft) and Chemical Room 9' x 6' (54 sq. ft.).

a. Prepare ceiling and walls to receive Kilz primer.

b. Paint ceiling and walls with Sherwin-Williams Sher-Color Exterior Architectural, A-100 Latex Gloss - Extra White.

c. Repair/replace exhaust fan unit in Chemical Room.
