IWQ 14-10 Blackburn Park Pavilion Renovation

General Scope of Service

- 1. Pressure wash the roof under decking and all exposed wood components.
- 2. Pressure wash the concrete slab and all tables/benches.
- 3. Replace damaged wood components, trim and fascia on the supporting columns.
- 4. Install additional trim on the upper part of the column, similar to that existing on the base.
- 5. Replacement of any damaged roof decking with fitted non T&G planking.
- 6. Stain all exposed wood components.
- 7. Apply and seal/clear coat all exposed wood components.
- 8. Remove and dispose of the existing roof shingles.
- 9. Install 30# felt underlayment on roof decking.
- 10. Install 26 gauge pre-painted (Hunter Green) standing seam metal roof with drip edge and all related flashing. The panels will be 16"wide smooth panel with 1 ½"snap-lock --seams and hidden fasteners.
- 11. Install 6"pre-painted (Hunter Green) seamless aluminum k-style gutters with hidden hangers and a minimum of four downspouts.
