

Introduction

The City of Brookhaven (City) was incorporated in late 2012 and started functioning in early 2013. The population of the City is around 55,000 (55,554 in 2019) and growing. The City of Brookhaven is a welcoming City with a diverse population. The City is bound on north by Interstate 285 and generally on the south by Interstate 85, two of the most important transportation arterials in Metro Atlanta. The City is located south of City of Dunwoody, east of City of Sandy Springs and City of Atlanta and west of City of Chamblee.

The City government is comprised of four districts represented by four Council Members and the Mayor. The City Manager serves as the Chief Administrative Officer.

Legal Requirements

The Americans with Disability Act also known as ADA was enacted by congress on July 26, 1990. Title II of the ADA applies to public entities, such as state and local governments, and the programs, services, and activities they deliver. This includes ensuring that paths of travel in the public rights-of-way are accessible according to ADA standards. Title II, Article 8, requires public entities to take several steps designed to achieve compliance with such ADA measures. This includes the mandate for the creation and implementation of an ADA Transition Plan. According to the federal regulations, the plan shall, at a minimum, include:

- A list of the physical barriers and their locations in a public entity's facilities that limit the accessibility of its programs, activities, or services to individuals with disabilities
- A detailed outline of the methods to be utilized to remove these barriers and make the facilities accessible
- The schedule for taking the necessary steps to achieve compliance with Title II
- The name/position of the ADA Coordinator responsible for the plan's implementation

The ADA Transition Plan is to be updated periodically until all barriers to accessibility are removed. This directive applies to all public entities who employ 50 or more people, which means the City of Brookhaven must have an ADA Transition Plan. By adopting an ADA Transition Plan, the City of Brookhaven Council demonstrates their dedication to providing accessibility (as defined in the ADA) to the Public Rights-of-way.



<u>City Infrastructure</u>

Parks Facilities

City inherited parks facilities within the City limits from DeKalb County. The following Parks Facilities have been transferred from DeKalb County to City of Brookhaven in Fall of 2014

- a. Ashford Park
- b. Blackburn Park
- c. Briarwood Park
- d. Brookhaven Park
- e. Georgian Hills Park
- f. Lynwood Park
- g. Murphy Candler Park
- h. Skyland Park

Administrative Facilities

City Hall is the administrative center providing various services to public. The City Hall operates in a leased facility and the City is seeking to move to a City-owned facility. City Administration, Community Development Department, Finance Department, and Public Works Department operate from the City Hall. The Public has access to these departments at the City Hall. City Hall is maintained by a contractor and responds to all the maintenance needs.

City Public Safety Building operates in a leased facility on Buford Highway. Public Safety Building houses the Municipal Court and the Police Department. This facility is maintained by a contractor and responds to all the maintenance needs.

Other Facilities

City also inherited all the infrastructure within the rights-of-way from DeKalb County. This includes sidewalks, ramps, signals and crosswalks. The City also has constructed 6.32 miles of sidewalks since incorporation of the City. All newly constructed sidewalks and ramps are inspected by Public Works staff and meet ADA standards. In addition, as part of private development, builders are required to construct sidewalk/multiuse path at the lot frontage based on the City adopted Future Sidewalk and Trail Network Plan. All private development work is inspected by Community Development Department Inspectors and meet ADA standards

Self-Evaluation

Park Facilities

City hired a consultant to performed evaluation of Parks facilities for ADA compliance in July 2016. A comprehensive evaluation report was completed by the consultant on August 15, 2016. These facilities were programed for upgrade to meet the ADA standards by City Administration.



A Parks Bond referendum was approved by the Voters in November 2018. The referendum included a Parks Master Plan to renovate/re-build six parks facilities in the City. All renovations and new constructions meet the Current ADA standards.

Administrative Facilities

City Administration has completed the evaluation of the City Hall for ADA compliance. City hired a consultant to complete the ADA compliance evaluation of Public Safety Building on August 12, 2016.

City Public Safety Building is maintained by a Contractor and responds to all the maintenance needs. The City maintenance contractor has completed various renovation work recommended in the evaluation report to meet the ADA standards. This work includes upgrades to Building Entrance, All restrooms, General circulation area, Dining spaces and work spaces and all accessible means of egress. A new 36,000 SF Public Safety Building is under construction and expected to be opened for public in Fall 2021. The new Facility meets all current ADA standards.

Other Facilities

The City performed a "Laser Truck" inventory of the sidewalks in first quarter of 2013 and curb ramps in third quarter of 2013 and identified 65 miles of sidewalks and approximately 900 curb ramps. The inventory also identified 164 sections of sidewalk termini with no ramps.

Over the past five years, the City has constructed sidewalks through annual Capital Improvement Program (CIP) funding and also accepted sidewalks constructed and dedicated to the City from private developers. Those sidewalks have been constructed to the ADA standards. The City has developed Design Standard details for sidewalk construction and provided to the Development Community. The City has a robust inspection program to ensure the facilities are constructed and accepted to the ADA standards.

The City also initiated a Bicycle, Pedestrian & Trail Plan in second quarter of 2015 and adopted the Plan in April 2016. This plan provides the City's vision for sidewalks and multiuse paths. All future infrastructure from this plan will be constructed to meet the ADA Standards.

The City of Brookhaven is committed to providing public facilities that are accessible to all members of the community. The purpose of this ADA Transitional Plan is to self-evaluate the pedestrian facilities within the City rights-of-way such as sidewalks and curb ramps. The City also committed to meet the obligations under Title II of the American with Disability Act (ADA).

City's ADA Transition Plan inventories all the facilities within the City rights-of-way, identifies the barriers of accessibility and priorities the improvements that needed to meet compliance.

Identifying Barriers to Accessibility

There are many different barriers and obstacles impact that the pedestrian mobility within the City of Brookhaven.



Transition plan considers sidewalks curb ramps and crossings at intersections as barriers to accessibility. When constructed or installed correctly, this infrastructure is not a barrier.

Barriers in the City infrastructure within public rights-of-way could be categorized into several groups.

- a. No curb ramp present: Sidewalk abruptly ends with no curb ramp present
- b. Substandard Curb Ramp: There are curb ramps present but detectable warning strip or proper landing not present
- c. Crosswalk does not present at the Ramp
- d. Sidewalk width is not 4' (minimum)
- e. Mailboxes and other encroachments are in the sidewalk

City of Brookhaven has constructed 6.64 miles of sidewalk since its incorporation. These sidewalks have been constructed to the ADA standards with curb ramp and proper slopes and detectable warning strips.

Sidewalk and ADA Ramp Inventory

City of Brookhaven has performed a sidewalk and ADA Ramp inventory assessment in Fall of 2019. This sidewall and ramp conditional assessment included physically walking every sidewalk and documenting the sidewalks and ramps that doesn't meet the standards. The conditional assessment was performed based on the following criteria:

Curb Ramp Quality (Excellent, Good, Poor, Not present)

Excellent – Curb ramp is constructed to GDOT/City standards, Detectable warning strip is present

Good – Curb ramp is constructed to GDOT/City standards, Detectable warning strip is not present

Poor – Curb ramp is not up to the GDOT/City standards, Detectable warning strip is not present

Not Present – No curb ramps present at the sidewalk termini

Scope of Work

City of Brookhaven has 65 miles of sidewalks in their inventory and approximately seven miles of these were constructed within last five years. Sidewalk width varies depend on the period it was constructed. All Sidewalks constructed after the incorporation of the City are a minimum of 5 foot wide.

City also has 890 curb ramps and 543 of those ramps are ADA Non-compliance. 164 sidewalk termini with no Ramp present.

Sidewalk Locating and Assessment

City of Brookhaven has a GIS Sidewalk inventory. This sidewalk data originally came from DeKalb County. Periodic updates were performed when a Sidewalk Capital Improvement project was completed. This information is approximate and not up to the GIS grade. Sidewalks completed as part of private developments are currently being mapped in the GIS system.



Scope of work includes locating all existing sidewalks to GPS grade and provide a GIS database to include the following information:

Start point GPS location (Northing, Easting); End point GPS location (Northing, Easting)

If width changes within a section of sidewalk, start end GPS location for those sections

Sidewalk width (10', 8', 5', 4' less than 4')

Sidewalk ranking based on condition and quality of sidewalk

Sidewalk Condition/Quality (Excellent, Good, Poor, Not present)

Excellent – Sidewalk width is 4' or wider, curb ramps resent on both ends of the sidewalk, cross-sectional slope is 2% or less

Good – Generally sidewalk is 4' or wider with small sections are less than 4' wide near pinch points, curb ramps present

Poor – Sidewalk section is less than 4' wide, no curb ramps present on both or one end of the section

Not Present – No sidewalk present

The City intends to use this ranking to prioritize funding for sidewalk improvements in annual budget

Curb Ramp mapping and Assessment

The City has no curb ramp data in the GIS System. A Curb ramp inventory work was performed in 2013 and this data was not mapped into the City GIS System.

ADA Ramp GPS location (Northing, Easting)

Ramp Type (A, B, C, D), Detectable warning strip present (Y/N)

Removing Barriers to Accessibility

City of Brookhaven eliminates the barriers to the City infrastructure as soon as practical. City has a sidewalk maintenance program driven by Citizen requests. Citizens can request through the City website and place a work request. Public Works staff prioritize the requests and perform the repair work and provide periodic updates to the Citizen who placed the work request.

Transition Plan Adoption

ADA Transitional plan was presented to the City Council on October 27, 2020 Council Work Session.

Public Input

The ADA requires that there are opportunities provided for the Public to provide input in developing the Transition Plan. Public comment period was included in the November 10, 2020 Council meeting prior to adopting the ADA Transition Plan.

ADA Reporting

Officials Responsible for Plan Implementation

The Public Works Director is responsible for the implementation of the ADA Transition Plan. The Public Works Director's responsibility includes annual budget recommendation to the City Council for implementation of the Transition Plan.

Public Reporting Process

The public complaint process is an integral part of the transition plan, as it helps the City understanding the heavily used facilities and prioritization of funding and schedule. Formal complaints or grievances regarding the ADA compliance of public facilities in the City rights-of-way can be made directly to City's ADA Coordinator using the ADA Grievance Form in Appendix D. The grievances can be filed by the following methods:

- a. Filling the form completely and mailing to the ADA Coordinator
- b. Filling the form completely and e-mailing to the ADA Coordinator at Rick.Stone@Brookhavenga.gov
- c. Filling the form completely and dropping it off at the City Hall during regular business hours

Grievance Procedure

- a. ADA Grievance Form must be completely filled with names, address of the person reporting and the brief description of the alleged violation(s) in one of the three methods.
- b. A complaint should be filed within 14 days of when the complainant becomes aware of the alleged violation.
- c. ADA Coordinator or his/her designee will investigate the alleged violation. ADA Coordinator or his/her designee may contact the complainant for additional information in writing.
- d. A written determination as to the validity of the complaint and the description of the resolution shall be prepared by the ADA Coordinator. A copy of this resolution shall be sent to the complainant within 14 days. If the Complainant failed to provide requested additional information, the response time may be extended beyond 14 days.
- e. The complainant may request to reconsider their case in instances where he or she is dissatisfied with the resolution. The reconsideration request must be made within 14 days of the issuance of the ADA Coordinator's written resolution.

Parks Facilities

All Parks Facilities were programed for upgrades to meet the current ADA standards as part of the 2018 Parks Master Plan. The Park renovation and ADA upgrades schedule is provided below:

Administrative Facilities

A new 36,000 square foot Public Safety Building is under construction. This new facility is a three-story building with an elevator. This new facility is scheduled to be opened to public in Fall 2021 and will meet the current ADA standards.

The current leased City Hall meets ADA standards and a City owned new City Hall, when constructed, will meet new ADA standards.

Other Infrastructure

The City of Brookhaven is committed to providing facilities within the City Rights-of-way that are in compliance with ADA. The City has taken steps to make sure this is achieved.

All new sidewalks within the City are constructed to meet ADA Standards.

Implementation Plan could be categorized in three groups.

Since 2019, City's annual paving program includes curb raising and construction and/or repairing of the adjacent curb ramps.

Sidewalk Standards and Design Specifications

The City's sidewalk design standards and specifications meet or exceed ADA Standards. All new sidewalks are constructed five-foot wide and all new multiuse paths are constructed ten-foot wide. A two-foot wide grassed median or a landscape buffer is required for sidewalks where possible and a ten-foot wide grassed median or a landscape buffer is required for sidewalks where possible

Sidewalks and multiuse path terminated with ADA ramp with the detectable warning strip. The cross-slope at the ramps shall be a maximum of 2 percent.

Since incorporation, the City has adopted various long-range plans including Comprehensive Transportation Plan, Last Mile Connectivity Study, Bicycle, Pedestrian & Trail Plan, Ashford Dunwoody Corridor Study and N. Druid Hills Corridor Study. These adopted plans promote alternative transportation modes particularly facilities that support pedestrian movement. The Public Works Department has been aggressively implementing the projects recommended in these plans which helps to increase pedestrian facilities that meet ADA standards.
