



We see the mission and vision statements as foundational, at the core of the City's identity, its DNA. It's a statement of timeless values.</li> <li>We saw as our charge to look at the city's M&amp;V through an equity lens, and to make recommendations to the City Council to ensure that the city at its core stands for equity, diversity, inclusiveness, and social justice. We wanted to gauge if, in 2021, the M&amp;V reflect the values, communities and aspirations of this new city.</li> <li>In our opinion, the current mission and vision statements are pretty generic and could be for any city. These statements don't reflect the vibrancy, diversity and special qualities of the City, and they don't reflect principles of equity.</li> </ul> |

There was no input<br>from outside the Council, and no process for community<br>engagement, no open discussions. Moreover, these statements<br>were not adopted by a City Council resolution. We feel that this<br>process was not transparent or inclusive, and we believe that the<br>statements do not reflect what the City stands for.<br>The statements don't address or celebrate the City's diversity, or<br>its commitment to equity, inclusion, and social justice. The<br>statements reflect the view of a narrow group of individuals, not<br>of the City's populace.<br>Brookhaven's population is very racially and ethnically diverse.<br>Whites account for just half of Brookhaven's population (50.6%),<br>and Hispanics represent 27.2% of its residents, Blacks 11.7%, and<br>Asian 8.1%. The city's diversity index is 76.5%, higher than for<br>DeKalb (67.1) and for the 11 counties in the metro region (71.9). |

We<br>also learned how other cities have created equity initiatives or<br>have mission and vision statements embedded with equity<br>principles.  |
|  | We also looked at some documents created way after cityhood<br>that seem to be a better reflection of the Brookhaven community<br>and its values than its founding M&V statements. In 2020, the<br>City released an arts and culture strategic plan titled <u>"Arts</u><br><u>Brookhaven: A Vision for Culture and Creativity in Our</u><br><u>Community."</u> On Sept. 22, 2020, the City Council passed a<br>resolution approving this master plan. This master plan, which<br>reached deeply into the community, celebrated the City's<br>diversity and elevated the importance of Buford Highway, can be<br>an inspiration for creating new mission and vision statements.<br>We read the book "Images of America: Brookhaven" (authored<br>by Valerie Mathis Biggerstaff and Rebecca Chase Williams), which  |
